TERMS AND CONDITIONS

Participants agree to be bound by these terms and conditions (the “**Terms and Conditions**”). Any information or instructions published by the Promoter about the Promotion at <https://samsung-wallet.s3.amazonaws.com/EnterpriseEditionGoogleWorkspacePromoT&Cs.pdf> form part of the Terms and Conditions.

The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 2000 Hillswood Drive, Chertsey, Surrey, KT16 0RS (the “**Promoter**”).

Promotion Period

2. The Promotion will commence at 00:01 (BST) on 1st October 2025 and close at 23:59 (GMT) on 31st December 2025 (“**Promotion Period**”).

Eligibility

3. To be eligible to participate in the Promotion you must be a business registered or operating in either the United Kingdom (including Isle of Man or Channel Islands) or the Republic of Ireland (“**Participant**”).
4. Employees or agents of the Promoter that are involved in the operation of this Promotion or anyone professionally connected to this Promotion are not eligible to enter.
5. Network providers, retailers, distributors, resellers and any person who purchases a Promotion Product (defined below) for resale or otherwise not as the user of the Promotion Product, may not participate in this Promotion and is specifically excluded as a Participant.

Offer

6. Samsung is offering a promotion (the “**Promotion**”) whereby Participants who purchase an eligible 2025 Enterprise Edition model smartphone or tablet as listed in Table 2 (“**Promotion Product**”) from a retailer listed in Table 3 below (“**Participating Retailer**”) between 1 Jan 2025 – 31 Dec 2025 (“**Purchase Period**”) will be eligible to claim a promotional code which can be used for a discount on a one (1) year subscription of selected Google Workspace plans as listed in Table 1 below (the “**Reward**”), subject to full compliance with these Promotion Terms and Conditions. Full details of the Reward is given at Table 1 below.
7. New Customers (as defined in Table 1) can use the promotional code to purchase at a discount either the: (i) Google Workspace Business Starter plan; or (ii) Google Workspace Business Standard plan. Existing Customers (as defined in Table 1) who already have an existing Google Workspace Business Starter plan subscription can use the promotional code to upgrade at a discount to the Google Workspace Business Standard plan.
8. **AppXite shall determine exact discounts on Redemption (as defined below). Minimum discount is 20% off.**

- (vii) Then provide your payment details and click "Confirm".

New Customers purchasing 21-300 licenses

- (i) Copy the Promotion Code through clicking the "Copy" button and click the "Redeem on Google" button;
- (ii) Click "I'm not yet a customer of Google Workspace";
- (iii) Paste the Promotion Code in the "Insert gift card or promo code" box and click "Redeem";
- (viii) Choose either the Business Starter or Business Standard plan by clicking "Select" under your chosen plan;
- (ix) Register your business domain by following the instructions on screen and click "Next". If you do not have a business domain you can register and purchase a new domain name on this page. The current price of a domain in the UK is £7.66;
- (x) Select the number of users / licenses required on the review and check out page and click "Next"; and
- (xi) You will then be directed to complete a form due to purchasing more than 21 licenses. You must provide your name, contact information and all other requested information. Once submitted the form will be reviewed by AppXite who will contact you to arrange and confirm your discounted subscription.

Existing Customers

Note that to receive a discount, Existing Customers must upgrade from Google Workspace Business Starter plan to Google Workspace Business Standard plan.
